3	All pieces must be ready for display and clearly labelled on the back or underneath with the artist's name and the title of the piece.
4	Each artist will be provided with a unique QR code which is to be displayed alongside their piece. This will allow the public to access the artist's contact details and further information.
5	RAGE will not handle any sales nor take commission. All sales will be negotiated directly between the customer and the artist, via the QR code.
6	Sold artworks must remain on display until the end of the exhibition.
7	The RAGE Committee will exercise all reasonable care in handling the works submitted, but will not be responsible for the loss of, or damage to, any pieces whilst in the custody of the RAGE Committee and/or its agents.
